**Submission of the South Worcestershire Development Plan Review**

This is to notify you that under regulation 22 of the Town and Country Planning (Local Planning) (England) Regulations, 2012 (as amended) the South Worcestershire Councils, comprising of Malvern Hills, Worcester City and Wychavon, submitted the South Worcestershire Development Plan Review (SWDPR), to the Secretary of State for independent examination in public on Wednesday 27 September 2023. In addition to the SWDPR an extensive library of supporting evidence and other documents has also been submitted. In due course the Secretary of State will appoint an independent Inspector(s) to oversee the examination.

A Programme Officer has been appointed to liaise between the Councils, the Inspector(s) and other parties throughout the period of the examination. The Programme officer will be the first point of contact for anything relating to the examination of the Plan and will be in contact with you as appropriate in due course.

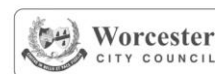
